

Modular Musings

The Steel City Steamer, 2003 Rocky Mountain Region Convention, is now. The Pikes Peak Division is committed to setting up a modular layout at the convention center in Pueblo for this event. A space of 20 X 40 feet has been set aside for us. Considering a roped off buffer around the modules, this provides a layout size of 12 feet wide by up to 32 feet long.

The layout will have all three track modules. The modules include: Wade Mountz 1 X 4ft, Joe Morgan 2 X 4ft, Jim Lipper 1 X 4ft, Bob Haggart 1 X 12ft, Alan Hutchins 1 X 4ft end bridge, Bill Poley 1 X corner, Gary Coleman 1 X corner, Jerry Hansz 1 X corner, Howard Smith 1 X corner, Chris Fox 1 X 8ft, Tom Lawhorn 2 X 4ft, Myron Gelsinger 1 X 8ft. In addition, the clubs 2 X 4ft bridges are available to fill in for any missing straight modules if necessary. At this time, it appears that transportation may be an issue for some of the modules and equipment. It may be necessary to rent a U-Haul or use one of Bob Haggart's vans to get everything there. If anyone can haul an 8 foot module and the rope posts to Pueblo on Friday morning or is willing to drive a van down, please call me at 380-8421.

We will plan to start setup of the layout on Friday morning starting at about 8:30 AM. The convention vendors and layouts officially opens Friday at 1 PM. They will also be open to the public on Saturday (8 to 5) and Sunday (8 to 3).

Deadline for Milepost material is two weeks prior to the regular meeting date. If you have material that you want published, please contact the Newsletter editor.

Since many of the module owners are already committed to jobs in support of the convention, it is important that other members of the Division will agree to operate the layout through the times it is open to viewing. Please look at your schedule and plan to help out. Call me at 380-8421.

Directions to the convention center at 320 Central Main Street are from I-25. Exit I-25 at exit 98 to First Street and go west to the second traffic light. Turn left (south) at the second light (Central Main). The convention center is southeast of the intersection.


